




















Origins of Now: ReBuilding Community



During his visit to the JASC, the Honorable Norman Mineta, who was interned at Heart Mountain and was himself a Resettler in Chicago, praised the exhibit as important in revealing little-known history.

An extensive series of programs to highlight and celebrate JASC's 60th anniversary year was planned by a committee of board and staff members.

Partnering with the Japanese American Citizens League (JACL), Chicago Japanese American Historical Society (CJAHS), Chicago Arts Partnerships in Education (CAPE), Asian Improv aRts Midwest, Fujima Ryu of Chicago and Tohkon Judo Academy, a full year of special events was presented to the greater Chicago community. The programs served as a first look into Japanese American culture and history for many, and a re-establishment of roots, values and heritage for those in the Japanese American community.

To focus our celebrations, an exhibit exploring the question *Why is there a sizable Japanese American population in Chicago?* was mounted. Using information, artifacts and photographs mostly pulled from JASC's Legacy Center archive, the historical component of *Origins of Now: ReBuilding Community* took shape. Alongside it, an installation of contemporary art created by Chicago Public School students added depth and emotion. An estimated 4,000-5,000 people – many of whom were learning about the history of Japanese in America for the first time – toured the exhibit.

While these special events were being planned and held, JASC continued to deliver high quality social and wellness services alongside its cultural and heritage programming and classes. The board and staff successfully completed about 80% of the Year 1 objectives from its strategic plan, and all remained focused on the three long-term goals:

- developing JASC as a destination center;
- continuing to reach out to the dispersed Japanese American population and broader community; and
- providing leadership in a consensus-building, facilitating manner.

Core Services

Since its founding in 1946, JASC has maintained a focus on providing muchneeded services to seniors. All of the agency's social services and wellness programs have in common a goal to allow seniors to maintain their independent living at a high quality of life for as long as possible. Originally founded to provide support to Chicago's Japanese Americans, JASC now serves a multi-ethnic population.



A variety of wellness programs aid community members in keeping in good health. Besides offering health screenings twice a year, in conjunction with the Chicago Department on Aging, JASC provides free flu and pneumonia vaccines and daily Golden Diners hot lunches for seniors. Tai Chi, taiko, folk dancing and judo classes are hosted, along with special presentations on prescription medicine insurance for seniors, and an AARP driver safety course.



During its 26th year of operation, Adult Day Services worked with an average of 42 seniors per month, and provided a total of 39,177 hours of care during the year. Seniors, who are either brought to JASC by their families or picked up by staff in the JASC bus, participate in a number of activities throughout the day to help stabilize and improve their mental, physical, emotional and social well-being.

Exercises, craft projects,

games and other group activities are conducted by the staff. A hot lunch, provided by the Chicago Department of Aging's Golden Diners program, and served by staff and volunteers, along with a morning and afternoon snack, keep the seniors energized during the day.

Staff nurses continually evaluate the participants' daily performances, and work closely with family members to make sure all needs are met as they arise.

Isolated Nikkei Elders

As part of JASC's commitment to reach out to the geographically dispersed people of Japanese ancestry, a research study, designed and implemented by Northwestern University's Buehler Center on Aging, Health & Society, was conducted (please see acknowledgements, page 12). This needs assessment investigated isolated Nikkei seniors in Chicago and the suburbs, to determine what services JASC should be providing that would enable them to maintain their independence and age with dignity.

Five areas of needs (psychological and cultural, safety, social, financial, and service and assistance) were identified, barriers and strengths were examined, and potential approaches and strategies for effective interventions were defined. The planning of the Wellness Outreach services continues.







JASC's Counseling department provides a variety of programs to support whole-person well-being, from individual therapy sessions to ongoing group activities. An average of 26 clients each month participate in the various programs.

JASC is able to provide psychotherapy to individuals and families in Japanese and English. Therapy sessions are reimbursed through

Medicare for qualifying clients.

The Jukunenekai support group at Heiwa Terrace, led by a volunteer, had eight attendees, on average. Eight senior women regularly attended the Out of the House group twice a week. They are led through exercises, crafts and group activities. They also just spend time talking with each other, an opportunity they would not get sitting at home alone.





Home Support Services is JASC's longest-running program. Staff members provide housekeeping services, as well as much-needed social interaction and emotional support to seniors living independently. Many of the program's clients live alone in apartments at Heiwa Terrace in the Uptown neighborhood. This past year 233 clients were served a total of 4,675 hours and provided with personal care, housekeeping, shopping, escort and related services.



Cultural Programs

JASC continues to be a vital resource for people interested in learning more about Japanese culture or pursuing excellence in their chosen art or sport. Cultural classes – including cooking, Sumi-e, Taiko, judo, dance, Tai Chi, Japanese language, Shamisen, ceramics and Origami – attract hundreds of people of all ages and ethnicities to the JASC each week.







2007 Community Service Awardee

Sharon Harada, JASC's assistant executive director and cultural and community affairs coordinator, was honored by the State of Illinois with a Humanitarian Service Award. It was presented to her by Secretary

of State Jesse White during Asian Pacific American Heritage month celebrations.

The award was made to Sharon in recognition of her 45 years working and volunteering in the Japanese American community.





Community Center

Having a meeting place, whether for a few or hundreds at a time, is a vital resource in any community. For Japanese Americans, JASC fulfills that role. Besides providing organizations with a place to meet, worship, dance, rehearse and learn, JASC is host to community-wide events like Kodomo Matsuri/Holiday Delight and Kagami Biraki New Year's Celebration.









Legacy Center

Known to researchers, historians and educators as a local treasure trove of Chicago's Japanese American history, the JASC Legacy Center and staff serviced 101 research and referral requests and accepted 35 donations this past year. The collection includes documents, photographs, publications and artifacts donated by members of Chicago's Nikkei community. The vast majority of the material used for reference or display in the Origins of Now exhibit was from the JASC's own archive.


Origins of Now Exhibit

Partnerships &

students and audience were treated to a special performance by JASC Tsukasa Taiko instructors.
















Performances

Dear Friends,

It is amazing that just a year ago we were looking forward to commemorating our 60th anniversary, envisioning the Origins of Now: ReBuilding Community exhibit and performance series. This was a year that exceeded expectations and had some wonderful surprises such as the visit from former U. S. Secretary of Transportation Norman Mineta, for our program, To Honor the Resettlers. This was a year of making meaningful memories enriched by bringing together longstanding friends and new friends in special and successful collaborations. Today, we are in a position to create positive waves, to celebrate diversity, to share our rich culture and heritage and to expand our community.

Strategic Plan Long-Term Goals

1. Destination Center

Create a destination center whose design showcases Japanese culture and tradition. The space will be flexible in use and be designed to accommodate a variety of programs and services.

A variety of highly professional programs, services and events would be offered at the center, with specialized programming being developed for families, children, teens, young adults and seniors. Concurrent use of the facility by different groups would be fostered, so that all members of the community can feel comfortable utilizing the facility at any time, and the environment helps build, not fractionalize that feeling of community.

2. Outreach

Reach out to the dispersed Japanese American population, offering broader services, partnering/coordinating with other organizations to share resources and consolidate efforts. This includes the development of the infrastructure and capacity needed for the support of outreach programming.

To meet the needs of a Japanese American population scattered throughout Chicagoland and the Midwest, satellite programming and services would be developed. The expanded staffing, communication, transportation and facility needs required to deliver and support these new programs would also be developed, so that they provided an alternative delivery site for some of the programs and services located at the destination center.

3. Leadership

Provide leadership in a consensus-building, facilitating manner among all Japanese American community organizations, and look for a commonality of purpose and opportunities for collaboration.

As the largest non-sectarian locus of Japanese Americans, and the organization with the most community resources, the JASC will strive to collaborate and coordinate with other community organizations for the betterment of all. The development of teens and young adults into community leaders will be another organizational focus.

定住者会が誇る 60 年の歴史

2006年7月から2007年6月までの1年は、定住者会の創設60周年を祝う1年でしたが、定住者会が常に日系人社会のセンター的役割を果たしてきたことから、まさにシカゴ日系社会の歴史を振り返る1年でもありました。

9月の富士まつりや12月のホリデー・ディライトなど従来の行事のほかに、10月のシカゴ藤間流の創立30周年記念リサイタル、アジアン・ジャズ・フェスティバル、12月の太鼓レガシーにも共催団体として参加。2007年は1月の闘魂柔道アカデミーの鏡開きに始まり、2月は日系市民協会シカゴ支部、シカゴ日系人歴史協会との共催で、恒例のデイ・オブ・リメンバランス」の記念行事を開催しました。

シカゴ日系歴史展 7ヶ月のロングラン

60 周年記念の最大行事、シカゴ日系社会の歴史展、「オリジン・オブ・ナウ:リ・ビルディング・コミュニティ」は、多くの外部団体やシカゴ公立校の生徒らの協力を得て開催され、3月10日のオープニングから10月26日の閉会までに4~5000人が入場しました。このような規模の大きな日系歴史展がシカゴで開催されたのは初めてのことでした。

移民、戦時キャンプへの強制収容、キャンプを出て生活再建を目指してシカゴに転住した人々の様子を写真やドキュメントのほかに収容所のバラックの一部を作り簡易ベッドを設置、トランクやキャンプで実際に使われた手作りの家具や工芸品、装飾品なども展示し、当時の暮らしを再現。新聞、テレビ、ラジオなどのメディアにも大きくとりあげられ高い評価を得ました。これらの展示物の多くは、定住者会の歴史資料室レガシー・センターのコレクションと、コミュニティから提供された貴重な資料でした。

5月2日には元運輸省長官のノーマン・ミネタ氏 をゲストに招いて、シカゴ日系社会の基礎を築いた 転住先駆者を称えて、"To Honor the Resettlers"hを 開催、歴史展を視察したミネタ元長官も子供の頃の 戦時体験を語り、会場は参加者で埋まりました。

壁画プロジェクト

この歴史展示会と平行して、2月からは2人の壁画アーティスト、マーティス・ズワイジンスキーさんとワン・カーロス・ペレズさんの指導でボランティアによる日系人の歴史と定住者会の活動をテーマにした壁画制作プロジェクトがスタート、毎週土曜日の午前中には小学生からシニアまで、平均20人前後の参加者が、日系人の歴史を学び、体験談を基にディスカッションを繰り返しながら5枚パネルの壁画の制作に励みました。

パフォーマンス・シリーズ

多くの祝賀行事の関連プログラムとして、日本の芸能文化にも焦点が当てられ、4,5,6月はJAS C司太鼓の和太鼓演奏、スティア・フライデー・ナイトのスケッチ・コメディ、シカゴ藤間流の日本舞踊と豊秋三味線アンサンブルの演奏がいずれも定住者会館で催され、日系人だけでなく、一般市民の注目をあびました。

また 5 月 20 日には 2005 年に開催され好評を得たファンド・レイジング・イベント「蛍飛ぶ」の第二回を記念行事としてウォルター・ペイトン・プレップ高校で開催、日舞と太鼓、三味線にブルースの野毛ヨーコさんをゲストに迎えたバラエティー・ショーで会場を沸かせました。

コミュニティ・ピクニック

このほか 2008 会計年度に跨りますが 8 月には他の日系団体と共にコミュニティ・ピクニックを開催しましたが、このピクニックは収容所から転住してきた一世、二世の先駆者たちが楽しみにしていた恒例行事の一つでした。

以上主な記念行事を拾い上げましたが、これらを 通して多くの非日系人にも日系人の歩んできた道 や定住者会の歴史と活動を認識してもらう良い機 会になりました。

アダルト・デイサービス

定住者会のソーシャル・サービスは、アダルト・デイサービス、カウンセリング、ホームサポート・サービスと大きく分けて3つの柱から成り立っています。

シカゴ市でも最も古い歴史を持つ定住者会のアダルト・デイサービスは、一ヶ月に平均 42 名のクライアントが参加、昨年度は 39,177 時間のサービスを提供することができました。体操やいろいろなゲーム、工芸、ダンスなどのアクティビティ、日米の四季の行事、健康管理や衛生、栄養などの指導、家にいては忘れがちな服薬も常勤の正看護婦が家族や医師と連絡を取りながら確認を怠りません。プログラムにはシカゴ市のオープン・キッチンと提携して、毎日日替わりメニューのホットランチ、スナック、地域に制限はありますが専用バスによる送迎も含まれています。

カウンセリング・サービス

カウンセリング・サービスは経験の豊かな日英バ イリンガルのカウンセラーが、個人、夫婦、親子の 心のケアからよりよい家族関係、職場の人間関係を 保つためのアドバイスをしています。2007 年度は 月平均26人のクライアントがありました。中でも グループ活動として、平和テラスで行われている、 日本語で話す「熟年会」は、居住者とボランティア の協力でずいぶん長く続けられています。また定住 者会で毎週火曜と木曜の2日行われている「アウ ト・オブ・ザ・ハウス」グループは、やはりボラン ティアとカウンセラーにより、家に閉じこもりがち なシニアが外に出て仲間や社会と接触することで、 生き生きした余生をおくれるように、体操、手工芸、 ディスカッション、フィールド・トリップなどバラ エティーに富んだプログラムが組まれており、習う だけでなくお互いに得意な分野では指導する立場 になるなど、毎回8人から10人の参加者が有意義 な時間をすごしています。このために引き続き送迎 をしてくれるボランティアを募集しています。

ホームサポート・サービス

定住者会のプログラムの中では最も古く、一世のために始められたホームサポート・サービスは、シニアが住みなれた自宅で快適に老後がおくれるように、掃除、洗濯、買い物、簡単な食事の準備、通院の付き添いや処方薬のピックアップなどをするホームメーカーを派遣しています。2007年度は述べ233人のクライアントに合計4,675時間のサービスを提供しました。

定住者会ではこれらのソーシャル・サービスを提供することで、シニアがナーシング・ホームなどの施設に入所することなくあるいは入所を出来るだけ避け、心身共に豊かな老後が遅れるようプログラムの企画に配慮しています。

日系高齢者のニーズを探る 総括冊子を発行

定住者会が今後どのようなサービスが必要とされているか知る為に、過去 55 年にわたるシカゴエリアの日系社会の変遷を調査し、その結果をまとめて 2002 年に発行した"The Nikkei Community assessment"に続いて、今年は市内の日系独居高齢者および郊外在住の日系高齢者の充実した老後のための質的ニーズの分析調査をまとめた総括冊子"A Qualitative Needs Assessment of Isolated Nikkei Elders, 2007"を発行しました。これらの調査結果は、今後の定住者会の運営方針に大きく影響するだけでなく、貴重な歴史的資料となるでしょう。

レガシー・センターの資料が大活躍

レガシー・センターでは創立 60 周年記念の歴史 展示会の資料の選択などで多忙な 1 年でしたが、加 えて、個人が持っている、家族の歴史的資料の正し い保存の仕方について、初のワークショップを開催。 今年度はリサーチャーのために 101 件の資料提供 をし、新しく 35 件の資料の寄付を受けました。こ れからもこれらの貴重な資料が、多く歴史の調査や 教育などの役に立つことでしょう。





Total Operating Expenses








